GST has been a valuable source of revenue for the Australian Government since 2000. Yet, despite more than 20 years of getting used to calculating, paying and reclaiming GST, businesses still struggle to adhere to ATO guidelines.

In March of 2017, the ATO identified almost \$350 million in unreported GST liabilities after contacting over 1,000 large business taxpayers.¹ Following the review, the ATO advised that businesses going through change are most at risk of reporting GST incorrectly. This includes businesses that are growing rapidly, restructuring, going through a merger or demerger, installing new accounting software or experiencing a change in accounting staff.

With the increase in the ATO's Justified Trust approach which seeks to provide assurance that taxpayers are paying the right amount of tax, there is an increased need for businesses to have robust tax controls frameworks in place and to provide objective evidence of the operational effectiveness of those controls to provide an independent level of assurance.

Paying the right amount of tax is modelled on the principles of effective tax governance so that tax risks and outcomes of differences between accounting and tax results are flagged to the market by the ATO

Increased scrutiny by the ATO on tax compliance means that organisations have to ensure they have:

- Appropriate resourcing models with robust governance practices; and
- Effective tax processes in the areas of compliance, reporting, and planning to allow the tax department to operate efficiently.

Are you up to the GST/VAT challenge?

GST/VAT is recoverable in more than 40 countries around the world. Each country has different rules and approaches, making GST compliance and reclaim a complex process.

Generally, GST compliance demands comprehensive policies for documenting business income, costs and associated charges ahead of any potential GST audit. And then there's the tricky matter of how to reclaim GST – and on what.

How to manage travel budgets and policies without hindering employees trying to nurture business opportunities

Top Tips for Successful GST Compliance and Recovery

At SAP Concur, we help business of all sizes get to grips with GST compliance and reclaim.

- 1** Introduce and enforce a company-wide policy for expenses covering what can and cannot be reimbursed to an employee
- 2** Audit all expenses, look out for fraudulent claims, and manage a fully traceable audit trail
- 3** Insist that employees ask for digital invoices or receipts and that they attach the images to expense claims as evidence for reimbursement, including tax invoices that are valid for Australian GST purposes
- 4** Make sure employees request invoice and receipts that include the date, supplier's name and GST number (i.e. Australian Business Number or ABN)
- 5** Introduce a mobile app to capture expenses in real-time to avoid lost or forgotten spend
- 6** Urge employees to provide business rather than personal details on check-in at a hotel, and to pay using a company credit card
- 7** Bring your travel and expense policy in line with GST requirements – it's best practice to use your GST reclaim process as the basis of your policy
- 8** Provide employees with support, guidance and training on GST regulations or changes to your travel and expense policies – and carry out regular spot-checks to ensure compliance
- 9** Ensure that the right people are reviewing and approving the right level of expenses as part of the approval process, including verification of the GST details
- 10** Embrace technology and invest in an automated travel and expense management solution to oversee and streamline the process end-to-end

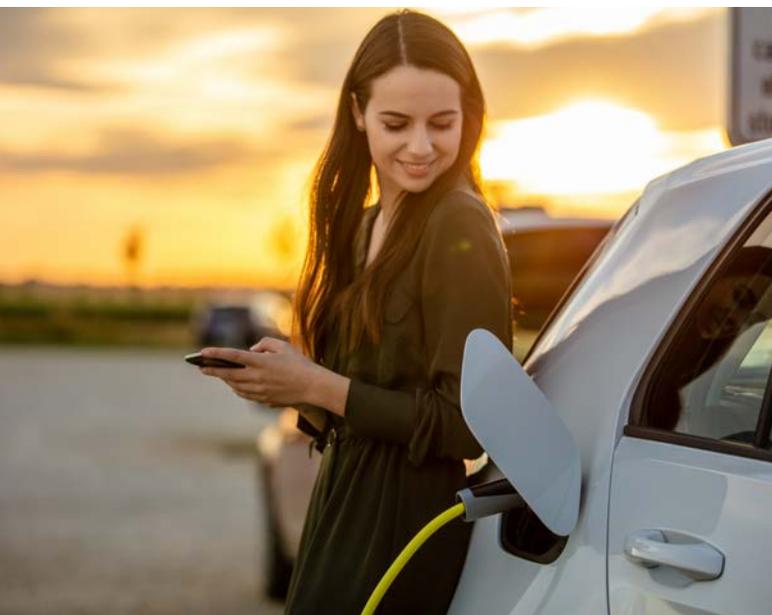
